

# WEBSITE PRIVACY POLICY OF THE MUSEUM OF BUS TRANSPORTATION

This Privacy Policy discloses the general privacy practices for The Museum of Bus Transportation (<a href="https://www.BusMuseum.Org">www.BusMuseum.Org</a> ) hereafter known as the "Site".

The Museum of Bus Transportation is committed to respecting the privacy rights of visitors to its web site. While visiting the Site, we may ask you to register and/or provide information that personally identifies you ("Personal Information") for purposes of interacting with the Site. To further the protection of your Personal Information, The Museum of Bus Transportation has adopted a set of information management guidelines (outlined below) that serve as the basis for our user relationships.

These guidelines have been developed with the recognition that Internet technologies are rapidly evolving, and that underlying business models are still not established. Accordingly, guidelines are subject to change. Any such changes will be posted on this page. Please see the Effective Date stated at the conclusion of this Policy.

### **Information Collected**

**Personal Information:** The only way we would learn your Personal Information is if you specifically submit that information to us, for example, through a request for addition, deletion, or change to our regular mailing list, purchase of our resources, donation, etc.

**IP** Addresses: The Museum of Bus Transportation does log IP addresses, or the location of your computer on the Internet, for aggregate data tracking, systems administration, and troubleshooting purposes.

By tracking usage, we can best determine what features of the Site best serve the users. We never give out information to others about individual usage. However, we do provide our aggregate information about our users, such as "2,000 people viewed our page today."

#### **Use of Personal Information**

We do not release personal information about you as an individual to third parties. The Museum of Bus Transportation may match aggregate (statistical) user information with third- party data. In addition, The Museum of Bus Transportation discloses aggregate user statistics in order to describe our services to potential donors, other third parties, and for other lawful purposes.



Additionally, The Museum of Bus Transportation will use reasonable efforts to ensure that only our volunteers with a "need to know" will have access to your information.

This Privacy Policy addresses the use and dissemination of information that we collect from you. To the extent that you disclose information to other parties, whether through, for example, online auctions, chat rooms, personal ads, or the like, or through other web sites throughout the Internet, different policies may apply. Since The Museum of Bus Transportation does not control the privacy policies of third parties, you are subject to the privacy customs and policies, if any, of that third party, and The Museum of Bus Transportation is not responsible for the use or dissemination of private information by that third party.

## **Children's Privacy**

The Museum of Bus Transportation cares about the safety of children and their use of the Internet. Therefore, in accordance with the Children's Online Privacy Protection Act of 1998, we never will knowingly request or solicit personally identifiable information from anyone under the age of 13 without prior verifiable parental consent. In the event that we receive actual knowledge that we have collected such personal information without the requisite and verifiable parental consent, we will delete that information from our database as quickly as is practical.
